INVITATION FOR PROPOSAL FOR THE LIVE CAPTURE OF GAME SPECIES FROM THWANE GAME FARM IN VAN ZYLSRUS

The Municipality hereby invites prospective service providers to submit proposal for the live capture of game species from Thwane game farm in Van Zylsrus

The John Taolo Gaetsewe District Municipality is the owner of the farm Thwane, 30 km South East of Van Zyl Rus. The farm is 6808 hectares and fully game fenced.

The successful capture team must be self-sufficient in terms of fuel, transport and catering. The ablution facilities will be provided for the capture operator and team. Boma facilities are not available at Thwane Game Farm, Van Zylsrus.

The successful operator will be required to enter into a contractual agreement with John Taolo Gaetsewe District Municipality. The capture operator will be required to remove all animals as specified below:

The capture operator will be responsible for obtaining any permits required for the capture, removal and translocation of the animals. Any tests (disease, pregnancy etc.) will be the responsibility of the capture operator who will cover all associated costs.

All pilots must comply with the legal requirements as set out by the CAA and must be in possession of a valid commercial pilot's licence. Copies of the pilots licences must be submitted prior to the capture commencing. Chemical immobilisations must be supervised by veterinarian.

The bid must include:

- A price per species
- Proof of liability cover
- Three independent client references
- Estimate of capture duration
- Any other relevant documentation

Bid documents at no costs are obtainable in the John Taolo Gaetsewe District Municipal website and E-Tender portal from Tuesday, **May 22th, 2018**.

Bidders will be evaluated for functionality on experience of individuals (50%), approach and methodology (25%) and proposed project plan (25%). Only bidders attaining a minimum of 60% on functionality will be considered.

The 80/20 principle will be applied, in terms of the Supply Chain Management Policy of Council. Council is not bound to accept the lowest or any bid and reserve its rights in this regard.
