Sealed bids clearly marked **“Bid No: 07-2018/19: “The Appointment of Consultants for assistance with the preparation of the Annual Financial Statements, quality and GRAP compliance review of the Annual Financial Statements and provision of assistance with the clearing of finding raised by the internal and external auditors for a period of 36 months”** must be placed in the tender box situated at the offices of the Municipality, 4 Federale Mynbou Street, Kuruman, 8460, **before 12:00 on Thursday, 13 June 2019** at which time the bid will be opened in public.

A compulsory briefing session will be held at **10:00 on Thursday, 06 June 2019**.

No late submissions will be accepted.

Please note that it is a prerequisite of the Municipality that all service providers are to be registered on the **Central Supplier Database**. It must therefore be understood that only bids from suppliers registered on the **Central Supplier Database accompanied by a Proof of Registration of Central Supplier Database** will be considered.

The 80/20 principle will be applied, in terms of the Supply Chain Management Policy of Council when bids are evaluated which is available upon request.

The John Taolo Gaetsewe District Municipality does not bind itself to accept the lowest or any bid and the Municipality reserves the right to accept the whole or part of any bid. No reasons for the acceptance or rejection of any bid will be given.

Bids will be adjudicated according to the John Taolo Gaetsewe District Municipality's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act (Act 5 of 2005) and the Preferential Procurement Regulations, 2017, as well as the Broad Base Black Economic Empowerment Act (Act 53 of 2003).
