Requests for formal written price quotations are hereby invited for the Supply, Delivery and Installation of Street Lights to the John Taolo Gaetsewe District Municipality as indicated below;

2	400	250 Watts Mercury Vapour Lamp Sodium
3	200	400 Watts Mercury Vapour Lamp Sodium

The service provider must be in possession of a COC Electrical Certificate.

Please take note that the works include material and labour therefore all equipment relating to installation will be incurred by the service provider.

Quotation documents with specifications and detailed information are obtainable at the Budget and Treasury Office (office hours: 08h00 to 13h00 and 14h00 to 15h30) of the Municipality, 4 Federale Mynbou Street, Kuruman, 8460, from **12:00 on Wednesday, 28 October 2015**.

Sealed Quotations clearly marked **“Quote No: 08/2015/16: Supply, Delivery and Installation of Street Lights”** must be placed in the tender box situated at the offices of the Municipality, 4 Federale Mynbou Street, Kuruman, 8460, before **12:00 on Thursday, 05 November 2015** at which time the quotations will be opened in public.

No late submissions will be accepted.

Please note that it is a prerequisite of the Municipality that all service providers are to be registered on the Municipality's Supplier Database. It must therefore be understood that only quotations from suppliers registered on the Municipality's Supplier Database or quotations accompanied by a completed Supplier Registration Application Form will be considered. The submissions of valid up to date SARS tax clearance certificates are compulsory. Supplier Registration Application Forms are available from the Budget and Treasury Office of the Municipality at Office Number 27.

The John Taolo Gaetsewe District Municipality does not bind itself to accept the lowest or any quote and the Municipality reserves the right to accept the whole or part of any quote. No reasons for the acceptance or rejection of any quote will be given.

Quotations will be adjudicated according to the John Taolo Gaetsewe District Municipality's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act (Act 5 of 2005) and the Preferential Procurement Regulations, 2011, as well as the Broad Base Black Economic Empowerment Act (Act 53 of 2003).
