**No late submissions will be accepted.**

Please note that it is a prerequisite of the Municipality that all service providers are to be registered on the **Central Supplier Database**. It must therefore be understood that only bids from suppliers registered on the **Central Supplier Database accompanied by a Proof of Registration of Central Supplier Database** will be considered.

The 80/20 principle will be applied, in terms of the Supply Chain Management Policy of Council when bids are evaluated which is available upon request.

#### **Pre-qualification criteria:**

- The bidder must be located in the Northern Cape Province
- The bidder must have Level 1 BBEE Certificate

Bidders will be evaluated for functionality on experience and qualification of mentors, approach and methodology and implementation plan.

The John Taolo Gaetsewe District Municipality does not bind itself to accept the lowest or any bid and the Municipality reserves the right to accept the whole or part of any bid. No reasons for the acceptance or rejection of any bid will be given.

Bid will be adjudicated according to the John Taolo Gaetsewe District Municipality's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act (Act 5 of 2005) and the Preferential Procurement Regulations, 2017, as well as the Broad Base Black Economic Empowerment Act (Act 53 of 2003).
