Remuneration:

Members of the Audit, Risk and Performance Committee will be remunerated in accordance with the JTGDM Audit, Risk and Performance Committee Charter approved by Council annually.

Requirements:

Applicants should have the competency, knowledge, skills and experience on the following:

- Performance Management System
- Legal
- Risk Management
- General management and Local Government
- Knowledge and experience in IT will be an added advantage

The term of office for the committee members shall be for a minimum period of three years.

Advise the Municipal Council, Political Office Bearers, Accounting Officer and Management on matters relating:

- Internal financial control and internal audits;
- Risk Management;
- Accounting policies;
- The adequacy, reliability and accuracy of financial reporting and information;
- Performance Information;
- Effective governance;
- Compliance with the Municipal Finance Management Act, the annual Division of Revenue Act and any other applicable legislation;
- Performance evaluation; and
- Any other issues referred to it by the municipality;
- Review the Annual Financial Statement to Provide the Council of the Municipality with an authoritative and credible view of the financial position of the municipality, it's effectiveness and its overall compliance with the act;
- Respond to Council on any issue raised by the Auditor –General in the Audit Report;
- Carry out such investigation into the financial affairs of the municipality as the council of the municipality may request;
- Perform such other function as may be prescribed.
